- D. To be a productive person by being involved in school, work, or training, or any combination on a daily basis, and to follow their rules and regulations.**
- E. To keep the legally prescribed curfew or that which is mutually agreed upon by my parent(s) or guardian(s), staff where I live, and my worker.**

- G. Participate in programs and services required by the Wayne County Department of Juvenile & Youth Services.**
